Offering numerous incentives, the property underwent a full environmental anlaysis in 2013 that found the site contained "a low potential for any significant environmental issues." Strategically located next to I-190 and many commercial and recreational destinations, the site makes it possible to grab a quick round of golf or a visit to Niagara Falls within minutes.
